

# Advance Campervan Rental Terms and Conditions



The Vehicle is rented upon the conditions shown on this page and upon the reverse hereof. This Agreement contains important Terms and Conditions which affect your rights and obligations under this Agreement.

ALL PRICES SHOWN INCLUDE GST:

## STANDARD RATES INCLUDE:

- unlimited kilometres
- Standard excess insurance cover
- Living Equipment
- Full water tank and gas Bottle
- NRMA on road assistance
- Extensive Travel Information pack
- Cleaning Fee
- 10% GST (Good and Services Tax)
- 2% local state tax

## MINIMAL RENTAL DURATION AND COSTINGS

Minimum Rental period: 3 days. Vehicle Rentals are calculated on a per calendar day basis ie: day of pick-up or drop off is always counted as a full day irrespective of what time it is collected or dropped off.

## LONG TERM RENTAL

Special Conditions apply for Rental of our Vehicle/s for more than 14 days. Details available on application.

## LICENCE AND MINIMUM AGE

A valid National driving Licence is required. Any National Drivers Licence produced which is not in English needs to be presented in conjunction with an official translation or valid International Drivers Licence. The minimum age is 21 years.

## DEPOSITS AND OTHER ASSOCIATED COSTS:

- A cleaning fee of \$100.00 AUD will be charged should the vehicle not be returned in a reasonable condition.
- Charging of such fee will be at the Managers discretion.
- The vehicle must be returned with the Toilet emptied, otherwise a cleaning fee of \$100.00 AUD will be charged.

Deposits and booking numbers for hires with a credit card (MasterCard or Visa) can be made over the phone and all Credit Card Information will be treated with strict confidentiality.

## CANCELLATION FEE

The fees for any cancellation are as follows:

- A \$75.00 AUD cancellation administration fee will apply to all cancellations, plus:
- 24 - 6 days prior to hire a fee of 15% of the hire is charged.
- 5 - 0 days including No Show will incur a fee of 100% of the hire payable
- A hire is termed a hire and if a Vehicle is brought back early, no refunds/monies will be returned.
- Hirer is responsible to check water and oil daily.

## IMPORTANT:

The Renter is fully liable for any damage to any Advance Campervan Rental vehicle or third party property if:

- A. Terms of the Rental Contract are breached.
- B. Damage to the Vehicle is caused by careless, wilful or reckless driving.
- C. Driving under the influence of alcohol or drugs.
- D. Driving on restricted roads.
- E. Water submersion or salt water damage caused through own fault. In the case of any damage to the Advance Campervan Rental vehicle or third party a second bond will be collected to cover the excess for any subsequent damage.
- F. Customer agrees not to place firewood, bricks, earth or other material in the vehicle as to cause misuse of the Vehicle. Customer is responsible for all damage to rented vehicle resulting from Customers negligence.

## ROAD RESTRICTIONS

Any vehicle hired out by Advance Campervan Rental is only permitted to be driven on sealed/bitumen or access roads.

## REPAIRS

Repairs of up to \$100.00 AUD may be affected without authorisation and will be reimbursed. Amounts above \$100.00 require approval for on-road assistance.

## VEHICLE RETURN

All Vehicles must be returned with a full tank of fuel. Refuelling at our Depot will incur a charge of \$1.90 AUD per litre of fuel.

Rentals subject to an additional fee if the Vehicle is not returned to originating Office. Fee of \$400.00 AUD plus the Cost of returning.

## OTHER RESTRICTIONS

No pets are allowed in any of Advance Campervan Rentals vehicles at any time.
